VII.2.2) Reasons for modification

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

Provision of services novated to London Borough of Barnet (LBB) following unforeseen reset of contract which required novation and extension by LBB. As part of contract extension, Contract Award notice modification was identified to clarify DPS Contract period, as well as, value. The estimated value per annum for this arrangement is 1,600,000 GBP. The budget for these contracts is held by Barnet Education & Learning

Service Ltd (BELS) and is funded through the service fee paid to BELS under the contract between the LBB and BELS. There are therefore no financial implications to LBB.
