## **VII.2) Information about modifications**

### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

To extend the contract period from 1st June 2022 – March 2023 (10 months).

### **VII.2.2) Reasons for modification**

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

The need for this modification was unforeseen as the COVID-19 pandemic resulted in training not to be able to be delivered for the 9 month period (March 2020-December 2020) due to government restrictions. This modification is to extend the time period for a 10 month period only. The original contract was awarded for 39 months and therefore the additional 10 months is well within the 50% permissible within the regulation. The modification does not alter the overall nature of the contract in any way.
