International visits, as mentioned above, are also of huge importance for RWM staff to witness existing facilities first-hand and improve their knowledge. RWM's engagement with UK media and key external stakeholders is similarly essential and the offer of a tour of underground facilities which already exist is a huge pull to attract interest and positive engagement, plus it further helps the international consensus narrative.

Similarly, technical contracts exist between RWM and SKB, further highlighting and demonstrating the unique expertise and knowledge SKB can bring to Radioactive Waste Management.
