The existing contract to deliver elective care Ophthalmology and Gastroenterology Services across Cheshire & Merseyside was placed on 1st April 2023 and expired 31st March 2025. This modification takes up the Contractual Option to Extend within the original contract and adds an additional one year to the contract term. As a result the modified expiry date is 31st March 2026.
