For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. The publication of this notice marks the start of the standstill period. The contract award date is 2nd May 2025, and the standstill period took place between 9th April 2025 and 21st April 2025. The business case included the recommendation to award the contract under Provider Selection Regime Process C and was approved by the ICB Strategic Finance and Commissioning

Committee on 28th March 2025. The contract will be for one year from 1st April 2025 to 31st March 2026, with an optional one year extension until 31st March 2027.
