Explanation:

The Department's 23 weather stations were all purchased from Vaisala. Since Vaisala are the original manufacturers of the various elements making up the various weather stations, only they can currently provide the management and maintenance that is required for these stations without considerable cost to the Department of replacing the stations or at least replacing many of the separate elements which go to make up a weather station.
