The service is Psychiatric Intensive Care Unit (PICU) inpatient beds. Psychiatric Intensive Care Units (PICU) are specialist wards that provide inpatient mental health care, assessment and comprehensive treatment to individuals who are experiencing the most acutely disturbed phase of a serious mental disorder. The contract has been awarded following Direct Award process B, at £989.00 per day for a nominal period of 4 weeks as the duration is unknown. The patient would be reviewed daily mon-fri and would be repatriated where clinically appropriate. Estimated total cost is £27,693 from 25th April 2025 to not known. The Trust had a spot purchasing arrangement with this provider in the past, and this is a continuation of that service for a new placement, now coming through the Trust, whereas previously it sat under the ICB. There were no alternative placements identified within the required timeframe.

The patient has no legal right to choose, but the Trust does not want to restrict the number of providers. This is highly specialised psychiatric services with limited availability nationally.

All known providers were contacted to ascertain whether they could provide the required service, only this provider responded in the required timeframe.
