SRUC's Consulting and Veterinary Services will co-locate to the centre in order to help bridge the relationship between industry and research, so promoting innovative new approaches in existing and new rural SME businesses. SRUC will work closely with Highlands and Islands Enterprise to replicate the success of their Pathfinder Accelerator programme, and Centre for Health Science in the animal health sector.

The project recently commenced RIBA stage 4 and a planning application was submitted to the Highland Council on 25th June 2021 for the development of the new two storey, 1,6060m² GIA building. To fulfil SRUC's requirements, the building will encompass a mix of office, research and professional services spaces.
