This will require the contractor to undertake sampling as designed and specified by our lead engineering contractor, Ramboll.

#### **II.2.4) Description of the procurement**

North Ayrshire Council in partnership with the Ayrshire Growth Deal Marine Tourism Programme are developing an extension to Ardrossan Marina by developing the currently derelict Montgomerie Basin in Ardrossan Harbour. The marina will site within and be a key element of the wider Ardrossan North Shore Regeneration Programme.

The marina basin will be developed through the addition of breakwaters tied to the adjacent pier and coastal revetment with dredging undertaken to achieve required depth.

The contract is currently programmed to commence in October 22 with a completion date of January 23. An optional extension of up to 3 months will be available.
