The Surrey and Sussex Cancer Alliance, hosted by Royal Surrey NHS Foundation Trust (RSFT), has awarded a contract for the delivery of the Targeted Lung Health Check (TLHC) Programme. Following a competitive process, tender responses were evaluated

The Surrey and Sussex Cancer Alliance, hosted by Royal Surrey NHS Foundation Trust (RSFT), has awarded a contract for the delivery of the Targeted Lung Health Check (TLHC) Programme. Following a competitive process, tender responses were evaluated against the five key criteria set out in the Provider Selection Regime.

The award decision was made by officers from the Surrey and Sussex Cancer Alliance, including representatives from the Programme Management Team, the Project Management Office, and Finance Managers. The decision-making panel also included the Net Zero Lead from Surrey Heartlands ICS, a Consultant Respiratory Physician from Surrey and Sussex Healthcare, a Consultant Radiologist, Clinical Nurse Specialists and members of the Cancer Programme Team from Frimley Health, a GP from Mid Sussex Healthcare and the Senior Public Health Programme Lead from Surrey County Council.

All evaluators signed a confidentiality agreement and completed a declaration of conflicts of interest. No declared or potential conflicts of interest were identified during the process.

The chosen provider was selected due to achieving the highest score across the key criteria used. The provider has been assessed and passed against the relevant key criteria and basic criteria.
