Interested organisations will need to log into the portal after the DPS has been released and search EEM0010 Consultancy Services DPS to locate the application questionnaire.

Once the DPS is released the initial application period will run for 30 days and EEM will then review all initial applications after the 30 day period. The DPS will then remain open for applicants to apply to join at any stage during the DPS term (The length of the DPS has not been agreed at this stage).
