Demand for autism and ADHD assessment and diagnosis services has increased significantly

in recent years, with waiting lists in some areas now years long. In order to address this backlog, many NHS organisations are outsourcing portions of this service to increase capacity, either on a short- or long-term basis. This Framework Agreement will provide a quick and compliant route to contract for these services.

The overall aim of the Framework Agreement is to provide an assessment and diagnosis service for autism, ADHD and/or combined autism and ADHD for both adult and paediatric

patients. For patients on the ADHD or combined pathway this may also include medication

prescribing, titration and review.

The term of the framework agreement will be 4 years.
