This is a Provider Selection Regime (PSR) intention to award notice. The awarding of this contract is subject to the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. The publication of this notice marks the start of the standstill period. No conflicts of interest were declared.

The criteria used to award the contract were mapped to the five key criteria, with a higher weighting applied to Integration, collaboration and service sustainability. This approach ensured that every critical aspect of the service was considered thoroughly.

5 key criteria selected: (1) Quality and Innovation: 20% (2) Value: 20% (3) Integration, collaboration and service sustainability: 25% (4) Improving access, reducing health inequalities and facilitating choice: 20% (5) Social value: 15%.

The existing provider demonstrated capability in meeting all five key criteria. All scored and pass/fail criteria were met by the provider to whom the relevant authority intends to award the contract. The provider has satisfied the requirements of the original contract and the proposed contracting arrangements are not undergoing significant changes.
