#### -Purpose

The Coal Authority operates over 70 mine water treatment schemes across the UK; these schemes primarily treat coal mine waters with a growing number of metal mine treatment schemes. In addition the Coal Authority has an active R&D department which undertakes a variety of UK wide mine water treatment trials.
