This variation is to update the contract in line with the new financial arrangements for NHS Norfolk and Waveney Integrated Care Board only. The funding is an additional £253,803.00 for the West Palliative Care Service, £1,000,000.00 for National Support (Month 12) but a Month 10 depreciation adjustment of -£861,000.00 to the Fixed Value.

The overall change to the Expected Annual Contract Value for 24/25 is a combined increase of the Fixed Value & Secondary Dental Fixed Value for NHS Norfolk and Waveney ICB totalling £773,588.00.

**VII.2) Information about modifications**

**VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

This modification is to update the contract in line with the new financial arrangements for NHS Norfolk and Waveney Integrated Care Board only. The funding is an additional £253,803 for the West Palliative Care Service, £1,000,000 for National Support (Month 12) and a Month 10 depreciation adjustment of (£861,000) to the Fixed Value. The overall change to the Expected Annual Contract Value for 24/25 is a combined increase of the Fixed Value & Secondary Dental Fixed Value for NHS Norfolk and Waveney ICB totalling £773,588.

Contract term remains unchanged. 1st April 2022-31st March 2030 (Inc 3 yr extension)

The modification does not render the contract or framework agreement materially different in character and the cumulative change in the lifetime value of the contract or framework agreement since it was entered into or concluded is less than 25% of the lifetime value of the original contract or framework agreement when it was entered into or concluded

This modification will bring the contract in line with the new financial arrangements for NHS Norfolk and Waveney Integrated Care Board and are permissible in line with Section 13 - 2A & 2B (ii) of The Health Care Services (Provider Selection Regime) Regulations 2023.
