Upon receipt of your expression of interest, we will share a document containing a small number of questions (no more than 5) around a couple of key areas of requirement that we would welcome industry views on (case management system, implementation period and accreditation). Depending on the level of interest that we receive, we would then look to invite all, or a cross selection of participants to come and discuss those specific areas. The intended outcome is to help inform our requirement going forward.

The OOM consultation concludes on 05 Aug 22 and we would look to invite participants before this date, although depending on availability and recognising that this is a tight timeframe in which to respond, some of the invites may be after this date.
