An invitation to tender was published on 2 November 2022 via Public Contracts Scotland Tender (PCS-T) with the closing date for submitting tenders 12 noon on 6 December 2022.

Tenders were invited on a Price / Quality basis. After being assessed on the relevant SPD criteria as outlined in the contract notice the following weightings were used to determine the most economically advantageous tender:

Quality (Technical) 60%

Price (Commercial) 40%

The successful Bidder was the one which achieved the highest combined Quality (Technical)

/ Price (Commercial) score.

Bidders were required to provide community benefits as part of their bid. They were required to choose from the Council's menu of Community Benefits to achieve the minimum points (200) required for the contract.
