The new service will provide a single provision for NHS Talking Therapies and Psychological Therapies for Severe Mental Health Problems across Mid and South Essex, ensuring that patients are seen by the right person, at the right time and on the correct pathway.

The aims and objectives for delivery of the Service include:

- Improving the health of our population and reducing health inequalities, by ensuring improved patient outcomes with a focus on quality of delivery across the ICS.
- Ensure patients have equitable offer across the board, while encouraging partnership working amongst organisations across the system.
- Enhance productivity and value for money, by reducing administration time, duplication, and overall management costs.

The total proposed aggregate value of the contract (including extensions) as advertised in the Find a Tender Service (FTS) is £92,503,175. The financial envelope which acts as an affordability cap for the purposes of the Process is £55,879,469 over the three-year term.

#### DECISION MAKING PROCESS:

The selected provider was selected due to achieving the highest scores across the key criteria used. The provider has been assessed and passed against the relevant key criteria.

Basic Selection Criteria was set out in the procurement documentation, the Selection Questionnaire (SQ) and were scored Pass/Fail. The Key Criteria was:

The selected provider was selected due to achieving the highest scores across the key criteria used. The provider has been assessed and passed against the relevant key criteria. As outlined in the procurement documentation, the key criteria contained Technical Questions. The raw weighting and applied weightings have been assigned per Key Criterion in accordance with its relative importance in line the assessment of this tender process as determined by NHS MSE ICB. The Key Criteria was:

- PSR Key Criteria 1 - Quality and Innovation - 42.00% Raw Weighting (out of 100%) / 37.80% Weighting (out of 90%)
- PSR Key Criteria 2 - Value - 8.00% Raw Weighting (out of 100%) / 7.20% Weighting (out of 90%)
- PSR Key Criteria 3 - Integration, Collaboration and Service Sustainability - 23.00% Raw Weighting (out of 100%) / 20.70% Weighting (out of 90%)
- PSR Key Criteria 4 - Improving Access, Reducing Health Inequalities and Facilitating Choice - 17.00% Raw Weighting (out of 100%) / 15.30% Weighting (out of 90%)
- PSR Key Criteria 5 - Social Value - 10.00% Raw Weighting (out of 100%) / 9.00%
