This decision was made on the basis that the winning bidder was the only one of the 5 bidders to pass all of the stage 1 pass/fail questions. Furthermore, the provider scored well on the basis of their responses to the key criteria questions. The providers bid was assessed against the key criteria with the following weightings:

Quality and Innovation: 40%

Value: 25%

Integration, Collaboration and Service Sustainability: 5%

Improving Access, Reducing Health Inequalities and Facilitating Choice: 25%

Social Value: 5%

On the basis of the providers responses to the key criteria, the panel assessed that they were confident that they could deliver the service.
