The Council intends to agree individual Statements of Work with the Delivery Partner which will define the outcomes we require within each work area. The payment approach will vary dependent on the statement of work, this will be agreed in advance; e.g. fixed price or capped and time and materials etc. There is no commitment to a minimum spend over the term of the contract. The maximum spend is limited to £4 million over the duration of the contract, excluding VAT. The contract terms is 2 years with an anticipated start date of 03 July 2023.
