The requirement is to supply Natural Gas to approximately 575 NHS Wales sites. NHS Wales undertakes its own energy pricing procurement and engages directly with the supplier to secure prices and volumes on its behalf.

A brokerage service is not required and the supplier is required to hold an OFGEM Supply Licence. Natural Gas volumes for all sites are secured under one portfolio, currently secured in advance on a flexible basis.
