The Elizabeth Line's engineering division is responsible for the Yellow Plant including the provision of rail milling and engineering train services to support various projects and maintenance activities that deliver essential improvement programmes.

The scope of work covers several types of assets which are used to support various track maintenance and project works activities:

- 1 x Railhead profiler - Linsinger MG31
- 2 x Engineering Trains - Robel Engineering Trains (This consists of 4no power cars and 2no wagons.)
- 1 x Infrastructure Monitoring Vehicle (IMV) Module
- Other supporting equipment
