The modification to the contract is required to enable the upgrade in Network Access Service circuit capacity at 7 digital hub and corporate sites from their current 1GB NAS bearer bandwidth capacity to 10GB, and at a further 154 DWP sites there is a requirement to increase their current bandwidth capacity from 100MB to 1GB.

Maintaining the technical requirement with BT is in line with contract scope and contracted delivery, allowing for economies of scale and mitigation of duplication of costs should DWP have changed Supplier.
