Nursery provision and out of school childcare, to include holiday offering is required for 0-11 years to support the military workforce. With surplus capacity being made available to the local community.

The contract will operate in addition to a licence to occupy the childcare building which will be managed by Defence Infrastructure Organisation (DIO).
