The service will include a centre-based day care service delivered from Haven Court, McAnany Avenue, South Shields, NE34 0JP to deliver 14 sessions per week with a maximum of 14 people per session, operating 7 days per week (196 places per week). The service will also provide an individual support brokerage service to assist people with dementia and their carers to access neighbourhood opportunities, that are either already commissioned at a neighbourhood level or delivered through the use of a direct payment.
