Part 2: Development and delivery of Food Labs training for professionals

Part 3: Development of Food Labs resources for families

The Food Labs sessions, training, and family resources are intended to support dietary diversity and healthy eating habits, with a focus on upskilling professionals already

working in community settings or with families.
