#### **II.1.4) Short description**

Monmouthshire County Council has recently developed a Strategy for Commissioned Domiciliary Care in Monmouthshire 2024-2034. This strategy sets out a plan for the redesign and recommissioning of care across Monmouthshire to meet the needs of current and future residents in the County. The strategy contains a high-level 2 phased implementation plan, phase one of the plan will focus on tendering for the provision of long-term domiciliary care and support in the South of the County from the autumn of 2024. Long term care and support will include the provision of personal care for older people, people with disabilities and mental health needs and people with dementia. We anticipate the tender will comprise of a series of block contracts, which will be the primary mechanism for the delivery of long-term domiciliary care and support in the South of the County. Phase 2 of the implementation plan will focus on the identifying and implementing of key actions for the North and Central areas of Monmouthshire, a full copy of the strategy is attached to this notice.
