This could be due to unplanned outages or when it will not take certain residual waste streams. Previous years usage estimates circa 6,000-12,000 tonnes per annum is likely to through this contract. The value of which is c£1.3m over an estimated term of 6 years.

The Council is aiming for zero waste to landfill as soon as possible, so it is important to procure a contingency residual waste arrangement that avoids landfill.
