The service will also provide social care support for all people living with HIV who need help to lead healthy and fulfilling lives.

- physical and on-line outreach
- face to face support
- development, delivery and evaluation of social marketing campaigns
- counselling
- community based HIV and sexually transmitted infection (STI) testing
- development and dissemination of printed and digital information and materials
- the provision of free condoms and lube
- structured peer support and work to address the role of drugs and alcohol in risk taking behaviours
