Expression of Interest - West Northamptonshire Alcohol and Drug Services - for providers who are not bidding as a lead Provider but wish to be considered by potential lead providers for partnership working.

This opportunity enables organisations to submit a brief summary of the services they provide, which will be included in the tender pack for the upcoming procurement process.

- Examples of similar roles or projects your organisation has undertaken.
- Evidence of outcomes or impact, including measurable achievements where possible (e.g., improved recovery rates, reduced waiting times, cost-effectiveness).
