This modification notice refers to the Lot 1 GDASS contract awarded at the conclusion of the framework tender process in July 2018 only. Additional services of those currently provided under the call off have been required due to the increase in demand as a result of the COVID-19 pandemic and the implementation of the Domestic Abuse Act 2021 neither of

which could have been foreseen by the Council. The original value of this initial call off contract was £6,410,000 GBP, it is now £7,560,000 GBP over the contract maximum term of 60 months (corrigendum notice FTS 2021/S 000-012952).

This initial call off from Lot 1 excludes any other call-off contract that may be awarded from the framework.

Overall framework value remains at £14 000 000.00 GBP.
