VII.2) Information about modifications

VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

A modification to NHS England's contract for the delivery of the Primary Care Support Services, which are essential administration services that underpin Primary Care in England. The modification agrees between the Parties to extend the Contract for a period of 18 months and confirms timeframes for invoking the Termination Assistance Period,

provided for within the Contract. This modification is made in accordance with the safe harbour of Regulation 72(1)(b) of the Public Contract Regulations 2015. In addition, we do not consider this to be a substantial modification and so the modification is also made in accordance with the safe harbour of Regulation 72(1)(e) of the Public Contracts Regulations 2015.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

Extension required to allow for a sufficient time to complete a procurement exercise. This will ensure uninterrupted service delivery during the re-procurement period and a safe transition and exit from the incumbent supplier to the new contract arrangements when it is awarded and established.

This Contract was procured under the Public Contract Regulations 2015 and the contract modification is executed under the safe harbour permitted in Regulation 72(1)(b) PCR 2015.
