Norfolk & Waveney ICB, Norfolk & Norwich University Hospitals NHS Foundation Trust and NHS England have signed a Memorandum of Understanding to provide support to NNUH to Undertake validation (technical, administrative or clinical) to deliver an increase in clock stops and validation percentages in line with the 2025/26 operational planning guidance. Under this agreement, NNUH will be paid £33 per patient removed from their waiting list, up to a maximum of £135,878 (CV096)
