NHS England and NHS Improvement South East (the Commissioner) seeks to commission a Mental Health Treatment Requirements (MHTRs) Service across the South East. This forms part of the wider Community Sentence Treatment Requirements (CSTRs) Programme which is a partnership between the Ministry of Justice (MoJ), Department of Health and Social Care (DHSC), NHS England and NHS Improvement (NHSE/I), Public Health England (PHE) and Her Majesty's Prison and Probation Service (HMPPS).

#### II.2.4) Description of the procurement

This notice is placed as a Prior Information Notice in order to facilitate engagement with potential providers, and relates only to pre-procurement market engagement.

The CSTR Programme aims to develop pathways to enable and facilitate the increased use of all three treatment requirements:

- Mental Health Treatment Requirements (MHTRs)
- Drug Rehabilitation Requirements (DRRs)
- Alcohol Treatment Requirements (ATRs)

For this commissioning exercise, MHTRs will be in scope, and DRRs and ATRs out of scope.

The key aims of the CSTR Programme are to:

- Reduce offending/re-offending
- Provide alternatives to short custodial sentences for offenders
- Improve health and social care outcomes

The contract term will be for a fixed term of 3 years with no extension option. It is therefore anticipated that the procurement exercise(s) will be undertaken and commenced late 2021 / early 2022.
