The aims of the reablement service are to prevent the need for long term care and support, prevent admission or readmission to hospital and delay or prevent the need for residential/nursing care.

Tenderers will be limited to being awarded one contract, irrespective if they have the highest scoring Tender for both Lots.

Camden Council is seeking to recommission/retender reablement services in the North East and North West of the borough. The intention is to appoint two providers with each one delivering approximately 20,000 hours of reablement support in their locality per annum. It is anticipated that a procurement process would start in November 2021 for new contracts to commence on or around 1st June 2022 for two (2) years and nine (9) months with no extensions.
