The service is for the provision of a Mental Health Conveyance Response Vehicle Service (CRV).

The purpose of this service is to provide safe and effective transport to convey specified cohort of individuals between the community (following Mental Health assessment), Emergency Department (ED), Health Based Place of Safety and Mental Health Inpatient Services. For individuals detained under Section 136 where ED is used as the Health Based Place of Safety, a sitting staff service will be provided.

The CRV service is for Kent and Medway NHS mental health patients and their escorts who meet the eligibility criteria.
