### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

Modification to add validation, increased clock stops and validation percentages (in line with the 2025/26 operational planning guidance) to the contract. Provider will be paid £33 per patient removed from their waiting list, up to a maximum of £52,724.

The contract term remains unchanged (1 April 2022-31 March 2030 (including 3 year extension))
