### VI.3) Additional information

Primary ciliary dyskinesia (PCD) is a rare (estimated between 1:26000 - 1:40000) genetic condition in which the microscopic cells in the respiratory system called cilia do not function normally. Ciliary dysfunction prevents the clearance of mucous from the lungs, paranasal sinuses and ears. Primary ciliary dyskinesia management services include services provided by Highly Specialist Primary Ciliary Dyskinesia Management centres including outreach when delivered as part of a provider network.

The core objective of this service is to ensure that all patients with PCD have access to the optimal standards of care to enable a reduction in the morbidity and mortality associated with the condition. This service is for all patients with a diagnosis of PCD over the age of 16 years.

The service expected to commence in 2023/24.

The anticipated contract duration for this service is 3 years, with an option to extend the contract up to a further 12-month period at the Commissioner's discretion.

It is possible that as a result of this exercise, a formal tender process will not be required but instead a simpler provider selection process will be undertaken. Where it is noted that competition is absent for a particular lot, the Commissioner reserves the right to direct award to provider(s) with no further competition. All providers will be notified of next steps following the conclusion of this market engagement exercise.
