The Secretary of State for Defence intends to award a 5-year contract to the University of Wales Trinity St David ("UWTSD") for the provision of a block release Ordnance, Munitions & Explosives degree course from August 2024 until July 2029 for Defence Equipment & Support (DE&S) employees. In accordance with the provisions of The Public Procurement (Amendment etc.) (EU Exit) Regulations 2020 SI No. 2020/1319), this procurement falls to be regulated under the provisions of the Public Contracts Regulations 2015 as amended (in particular by SI 2020/1319).
