This is a call for expressions of interest to attend an Engagement Event for NHS Lancashire and South Cumbria ICB's Tier 1 Ophthalmology Service.

Lancashire and South Cumbria ICB currently commission a range of primary eye care services via a range of different of providers which is delivered in all areas. This will improve access for patient care, deliver care closer to home and overall provide an excellent patient experience whilst delivering a cost-effective service.

As part of this procurement process, the authority is intending to identify one provider to deliver a Tier 1 Ophthalmology Service across the whole Lancashire and South Cumbria ICB.

The contract will be for 3 years with a possible 2-year extension. The estimated contract value per annum is £3,261,000. It is estimated that there will be 1% growth year on year.
