#### **Description**

- Clear processes and timeframes for maintenance and developments, to include an agreed SLA
- In addition to the Manchester Central website, we also have two dormant websites (both Drupal) that will require hosting until a decision is made regarding relaunching the sites.

Potential additional future requirements:

- Support with Google Analytics 4 to allow us to track how users are navigating and engaging with the website allowing us to make relevant improvements.
- Ability to support with wider digital presence e.g. Google AdWords and Social Media
- Additional training/support to guide us through new processes/ programs if required
