The Mortuary service is to provide storage of deceased residents whilst being investigated by the coroner. This service will be solely for patients who are deceased on arrival (DOA) or whom pass away in the Emergency Department and require post-mortem. Normal mortuary service for patients who pass away while receiving treatment is part of NHS storage arrangements for deceased, and not part of this Contract.

LBH would like to hear from organisations who have experience in this area of provision.
