Following evaluation of responses to the SQ, it is envisaged that the five (5) highest scoring Bidders, up to a maximum of eight (8) Bidders, who pass section one to seven will be deemed to pre-qualify for short listing to the ITT stage. If in any case Bidders have equal points, the Authority reserves the right to select the Bidders based on: a) Highest combined section six and seven scoring; if still equal b) Highest section six scoring; if still equal c) Bidders will progress to the ITT stage. When there is a distinct gap in the final scores, this may be used to determine the exact number of Bidders invited to tender.
