#### **II.1.4) Short description**

The DNWP will be the successor of the existing Decommissioning Delivery Partnership (DDP) which is a 10 (5+5) year arrangement due to end in March 2026. The DNWP multi partner framework has an estimate value of £3bn over a 15 year (9+6) duration. The scope for this procurement covers the full suite of construction, demolition related works, associated technical services (including safety case and design) and waste management required to deliver decommissioning tasks and projects. These works will be deployed across nuclear facilities on the Sellafield site that are in operations, post-operation clean out (POCO), decommissioning or demolition stages of the asset lifecycle.

Remediation spanning the decommissioning of redundant facilities and managing land quality ahead of beneficial reuse. The remediation of the site towards the agreed end state requires each facility, once operations cease, to be systematically decontaminated and decommissioned, with all waste being responsibly managed.

This will include support in the design and deployment of effective processes and technologies that optimise end-to-end value in waste management across the enterprise. It will only cover waste management support on the Sellafield site, though the service provider will be expected to closely collaborate with Nuclear Waste Services (NWS), an NDA group subsidiary.
