Jisc anticipates that individual orders under the agreement will use a simple process, making use of bidders' terms and conditions, subject to the presence or absence of certain terms as set out in Appendix 2 of this document.

Jisc wishes to set up an agreement that will last for a maximum overall term of eight (8) years. The initial term will be 4 years with two further extensions of 2 years each, up to the maximum term of 8 years. Individual orders placed via the agreement may last for longer than the duration of the framework agreement.

Jisc cannot guarantee and makes no representation concerning the level of expenditure through the agreement in any given year, however experience with previous agreements of this type indicates that up to £10 million may be expended during the lifetime of the agreement. It should also be noted that there will be no minimum commitment of spend through this agreement either.
