This Prior Information Notice (“PIN”) has been published by the Regional Business Services Organisation (“BSO”) Procurement and Logistics Service (“PaLS”) on behalf of the Northern Health and Social Care Trust (NHSCT). This notice relates to the planned procurement of services classified as ‘Social and Other Specific Services’ under Schedule 3 of the Public Contracts Regulations 2015 (“the PCR”) which will be subject to the provisions of Chapter 3, section 7 of the PCR, otherwise known as the Light Touch Regime (“LTR”). It is anticipated that the tender will be advertised in early autumn 2023. The procurement exercise will be conducted in accordance with the information contained in any final published tender documentation. There is no guarantee a procurement process will run. The NHSCT wishes to carry out pre tender market engagement with interested providers using a pre tender market engagement paper CfT reference 4923819. The purpose of this PIN and the paper is to raise awareness of an upcoming procurement; gauge the level of interest in the provision of such services; receive feedback from the market by outlining the Trusts proposals for the delivery of this service, its procurement plans and requirements, in advance of any formal tender process.
