Essex County Council (ECC) have successfully entered all eight country parks into the Countryside Stewardship Scheme (CSS). This is a five-year scheme, with the aim of making further improvements to the ecological value of the parks through enhanced management. The scheme funds ongoing annual management, but also 'one off' capital payments which supports infrastructure improvements.

ECC is seeking an expert contractor/s that can deliver these capital works to the very highest standards, ensuring ECC is compliant and therefore able to receive grant funding as budgeted and achieve the improved ecological enhancements. The works include forestry trackways, fencing and water supply.
