This is because General Dynamics UK Ltd are the Original Equipment Manufacturer (OEM) and Design Authority for the FHD platform, which has been in-service with the MoD since 2012 and supported by this supplier since then. As the OEM they are the only supplier with the necessary technical data and required skills and experience to build FHD TDPs.
