The Council wishes to seek multiple Providers to deliver Summer Holiday Activities with Healthy Food for Children in Receipt of Benefits-related Free School Meals within the boundaries of County Durham.

This project utilises DfE funding which is for school aged children in receipt of benefits related free school meals.

All providers must meet DfE framework of standards as below:

- Food Provision
- Enrichment Activities
- Physical Activities

- Increasing Awareness of Healthy Eating, healthy lifestyles, and positive behaviours
- Signposting and referrals and supporting families
- Safeguarding
- Policies and Procedures

Please note - sessions do not need to be exclusively for children in receipt benefits-related Free School Meals. Alternative funding may be sourced by the organisation to fund children ineligible for DfE funding i.e parents/carers may be charged for sessions by the activity organisation.

Description of possible extension:

Successful Providers' contracts, as delivered under the Summer 2025 holiday provision, may be extended/varied to cover delivery in the Christmas school holiday period. At the sole discretion of the Council, providers will be identified and approached for Christmas delivery, this is likely to be dependent on successful achievement from Summer 2025 delivery under this contract and Commissioners professional judgement.

If Successful Providers meet the threshold that the Commissioner deems as successful delivery, they will be emailed a proposal form for completion for the next school holiday period. The same evaluation criteria will be applied to the subsequent proposals.

Where this is the case successful providers will be updated regarding the scope of delivery.
