Leeds OASIS will provide short term emotional and practical support for people who are assessed by the Crisis Resolution Intensive Support Service (CRISS) or Older Peoples Intensive Home treatment Team (IHTT) as needing additional support to avoid admission to hospital. The house will deliver person centred support in a safe, comfortable environment without the often stigmatising effects and restrictions of a hospital admission. Residence in the House will be in order to support the person through the initial "Crisis" period and may be for as brief a period as 24hrs, but will be no longer than a maximum of 7 days.
